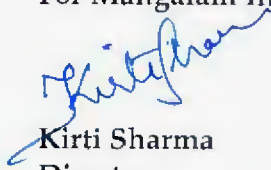

- 5 The constitution of Committee of Creditors (COC) u/s 21 have been constituted on 05.06.2018.
- 6 Previous year/period figures have been regrouped and rearranged wherever necessary in terms of current period grouping.
- 7 The results include figures for the period 1st April to 15th May, 2018 ie before the CIRP was initiated by the Honourable National Company Law Tribunal. These figures have not been verified by the Resolution Professional.
